Dear Parents/Carers,

Lyneham Primary School is committed to providing a technology rich environment for our students as our community believes the use of Information and Communication Technology (ICT) is fundamental in assisting teaching and learning in all areas of the school curriculum.

The use of web-based learning resources and cloud-based storage has risen steadily over the last decade and are increasingly being used by teachers across the Directorate to improve student learning outcomes.

Teachers make decisions designed to assist students in their learning. Sometimes it is beneficial for students to utilise services provided by third party web-based providers. Types of services provided by these service providers include online content creation, collaborative tools, online educational games, and various administrative programs for tracking student assessment data.

As our school is registering with several web-based service providers that require some personal information about a child in your care, we are obliged under the Commonwealth Privacy Act (1988) to advise you of the reasons for collecting the information, what will be done with it and who else may have access to it.

Page 2 of this document provides a list of the web service providers we would like to use, along with summaries of the way we believe these services can enhance learning and teaching, plus links to each service's *Terms of Use* agreement. We believe that the sites listed make sufficient effort to protect the privacy of their users as outlined in their privacy policies (see links on p.2).

Lyneham Primary School Acceptable Use of ICT Code of Practice for Students

When using ICT resources at Lyneham Primary School (including the internet, email, Digital Backpack, Google Apps for Education (G-Suite), Oliver Library, Seesaw, iPads, IWBs etc):

- I will use school devices only with the permission of a teacher.
- I will follow all instructions from teachers when using school devices.
- I will not let anyone else know my passwords.
- I know that I am responsible for anything that happens when my account is used.
- I know that the school and the Education Directorate receives information about anything that I send or receive.
- I will tell my teacher if I think someone has gained access to my account.
- I will make sure any work that I wish to have published, any email I send, or any comments I post are polite and carefully written and presented.
- I will respect other students' work and ensure appropriate feedback about individual responses.
- I will not read other people's emails.
- I will not tell anyone my address or telephone number or the address or telephone number of anyone else or send/post photographs of myself or others.
- I will use material from other websites only if I have permission to do so.
- If I use material in my work that I have found on the internet, I will say where it comes from.
- If I see or receive any information on the computer that makes me feel uncomfortable or is inappropriate I will tell a teacher straight away, or report it using the Cyber Safety Button on the Digital Backpack.
- I will not damage or disable the electronic devices, software systems or computer networks of the school.
- I will not send, create, show or search for things that might upset others.
