### VOLUNTARY CONTRIBUTIONS FOR 2021

Dear Families,

Each year we ask for your support for our school through your voluntary family contribution. The school receives some funding directly from the Education Directorate to provide for the educational needs of the students and covers only some school expenses. ACT schools may request voluntary contributions to supplement the Directorate funding.

Voluntary contributions are an important part of our school budget and assist us in ensuring that we can offer the best possible education and resources for students at Lyneham Primary. The School Board, which includes parent members, works to formulate the year's school budget. The money raised through your voluntary contributions directly benefits all students. **The Board decided last year that all voluntary contributions will be directed to the newly established Library Fund.** This is for two key reasons:

- 1) The library manages a wide range of resources to support teaching and learning across the curriculum, including:
  - a. Current, relevant reading and reference materials (in print and digital formats), carefully selected to meet the needs of our students and teachers and support learning across ALL curriculum areas: English, Mathematics, Science, Technology, Humanities & Social Sciences, Visual Arts, Music, Dance, Drama, Media Arts, Health & Physical Education, French
  - b. Online subscriptions to services to support learning, such as *Storybox* or *Britannica Online*
  - c. Information Communication Technology equipment & devices e.g., iPads, Chromebooks, robotics equipment
- 2) **Donations to the Library Fund are TAX DEDUCTIBLE**

**Last year your generosity enabled us to purchase more books for our library, continued subscriptions to *Reading Eggs*, *Mathletics* and *Britannica Online*, sporting opportunities for students and new equipment and furniture for the classrooms.**
